## **PRIVACY COLLECTION STATEMENT**

### **Collection of your personal information**

We may collect personal information from you in a variety of ways including when you enter such information into our websites and social networking services such as Twitter and Facebook, when you seek employment, when you complete competition entry forms, surveys, incident & visitor records or forms, on CCTV footage, use your credit card or enter into contracts or on-line transactions, send us emails, at meetings or on the telephone or at front gate.

### **How we use your personal information**

### **Disclosure**

- B. our service provider Magic Memories (Aust) Pty Ltd so you can make in-park purchases of photos as such disclosure will enable them to create an online account for you and to send a link by email to you to allow you to access your photos; and
- C. our related bodies corporate
